### **GM Monitoring Report**

For the month of July 2021, the policy being monitored by our GM is as follows.

# **Policy III-6: Financial Conditions and Activity.**

"With respect to the actual, ongoing financial conditions and activities, the General Manager must not cause or allow the Cooperative to be unprepared for future opportunities, the development of fiscal jeopardy, or key operational indicators to be below average for our industry." Sevananda's Accounting Manager, Edmund Richards gives an overview of there being loss over the last 4 quarters in sales. The margins have been consistent; however, the profits and customer count have been trending downward. Sevananda should be looking at \$200K/wk. in sales and is currently at about \$140K/wk in sales. He believes sales have been affected by COVID and Sevananda's mask wearing mandate causing a reduction in traffic in the store.

Ahzjah Simons speaks on how Sevananda's Deli and Bulk have taken a strong hit over the year. For the remainder of Quarter 2 Financials there will an emphasis on increasing the sales through marketing, promotions and separate revenue generators. Sevananda has launched its new app, targeting the technically driven customer base. With the current sales Sevananda still meets expectation for being in the benchmark, being in the benchmark and disclosure of unusual circumstances.

Jasmine S: Who gives technical support on Sevananda's app? Ahzjah S: I believe Sevananda operations does, however I will check with Marketing Manager Sharlise Lowe.
